Sealed Bids for the construction of the **ARPA Plant 1 Generator project** will be received, **from all prospective Bidders**, by **Leroy-Tours-Gerald WSC**, at the office of the **Office Manager, 312 W. Commerce Street, Leroy, Texas 76654**, until **2:00 P.M.** local time on **Tuesday, November 19, 2024**, at which time the Bids received will be **publicly** opened and read. The Project consists of constructing a **generator and associated electrical improvements at the Leroy-Tours-Gerald WSC Plant 1.**

Bids shall be on a lump sum and/or unit price basis, with additive alternate bid items as indicated in the Bid Form.

The successful Bidder, or Bidders, will be required to furnish a Performance Bond and Payment Bond each in the amount of the contract written by a responsible surety company authorized to do business in the State of Texas and satisfactory to the Owner.

The award will be made on the basis of the lowest responsible bid. The Owner reserves the right to waive any informality in the bidding and to reject any or all bids.

This project is being supported, in whole or in part, by the U.S. Department of the Treasury, in utilizing the U.S. Department of The Treasury Coronavirus State and Local Fiscal Recovery Funds (ARPA) program and is subject to all applicable Federal and State laws and regulations. Attention is called to the fact that not less than, the Texas Prevailing Wage rates, as issued by the Department of Labor, must be paid on this project.

In addition, the successful bidder must ensure that employees and applicants for employment are not discriminated against because of race, color, religion, sex, sexual identity, gender identity, or national origin.

All contractors/subcontractors that are debarred, suspended or otherwise excluded from or ineligible for participation on federal assistance programs may not undertake any activity in part or in full under this project.
