USDA Arsenic Project

Final plans are pending easement acquisition. With the removal of the potential reroute around Uptmore/Snider, we will submit to TCEQ by the end of this month. We can add any minor easement concessions prior to bidding should they come up. We are also ready to coordinate with your selected surveyor regarding any easement surveying required.

As reported by the office manager a certified letter has been mailed to all affected property owners that have not been previously contacted. to the website relating to the acquisition of easements & the map was provided by the engineer. There will be surveys required on some of the easements. We sought proposals from 3 different surveying companies: Eagle Surveying, Hilco Surveying & Blackland Surveying. Based on price, timeline & professionalism it was decided to go with Blackland Surveying.
